

## **Fast Set Supports Limited Warranty Details**

**Fast Set Supports, LLC, herein referred to as “Fast Set Supports”, warranty obligations are limited to the terms set forth as follows:**

- **Fast Set Supports warrants all Fastset® Tables and Fast-Attach Line of Accessories to be free from manufacturing defects under normal use for a period of Three Years from the date of retail purchase by the original end-user purchaser.**
- **Fast Set Supports warrants all soft products, such as cases, scrims, covers, etc. to be free from manufacturing defects under normal use for a period of One Year from the date of retail purchase by the original end-user purchaser.**
- **If the product is no longer manufactured by Fast Set Supports, and qualifies for repair under the warranty program, the product will be replaced with the closest comparable product as determined by Fast Set Supports.**
- **This warranty does not include damage to the product resulting from normal wear and tear, accident, misuse, improper installation or operation, or unauthorized repair or alterations.**
- **The Limited Warranty does not apply to any non-Fast Set Supports products or sub-brands even if packaged or sold with other products.**
- **Should the product become defective within the warranty provisions, Fast Set Supports will elect to repair or replace the product free of charge at our option, including free return postage, provided it is delivered prepaid to Fast Set Supports.**
- **Fast Set Supports may elect to send original end-user new or refurbished customer-installable replacement product or parts.**
- **Proof of purchase in the form of a dated receipt must be submitted with the returned product.**
- **All products needing to be sent to Fast Set Supports for repair or replacement must have a Return Authorization Number and will be returned to the sender un-repaired if one is not included. Please email your request (with explanation of problem) to Customer Support at [support@fastsetusa.com](mailto:support@fastsetusa.com) for a Return Authorization Number and return instructions.**
- **It is the sender’s responsibility to pay for shipment to Fast Set Supports.**
- **If the product is determined to fall under warranty, Fast Set Supports will pay for return shipping to the customer within the contiguous 48 states.**
- **If a replacement product or part is provided, the original product or part becomes the property of Fast Set Supports.**

**Should Fast Set Supports deem a product non-warranty, repair services or replacement parts may be available. Fast Set Supports will contact the sender with repair options.**
